Upon a motion by the Chair, seconded by the Secretary, it was moved that H.E. Dr. F. H. von Zeppelin be asked to act as the Lieutenant Grand Master of the Order, beginning during the year of 1956. Passed by unanimous vote.

The Chair read correspondence of interest to the meeting.

The membership and C edentials Committee submitted a list of names and ranks for the approval of the meeting. On a motion by the Chair, seconded by the Secretary, it was moved that the names be accepted for membership and recorded in the archives.

The Chairman then asked the members to join in the Lord's and a prayer for the repose of the souls of the departed unights.
